ABOUT THE NAFTA STEEL IMPORT MONITOR AND GRAPHICS:

The NAFTA Steel Import Monitor is part of a large intra-NAFTA governmental effort to cooperate under the Security and Prosperity Partnership (SPP). The goals of the North American Steel Trade Strategy are greater levels of cooperation across NAFTA, increased awareness of steel trade issues and a more unified voice. The NAFTA Monitor is one piece of the greater effort that will provide detailed and timely statistics on steel imports to NAFTA nations. The monitor will be updated on a monthly basis with import data from Global Trade Information Services, Inc. (GTIS). GTIS is the official data vendor of Canada and Mexico. The monitor shows tables about aggregate steel import patterns in the trading bloc as a whole.

The NAFTA Steel Import Monitor shares accurate, close to real-time aggregate volume, value, and average unit values for steel imports through an easily accessible website. The monitor uses information from all three NAFTA countries, which are collected from the U.S. Census Bureau, Statistics Canada, and the Mexican Secretary of Economy. The data will be updated on a monthly basis as GTIS receives them, and tables will be provided at both yearly and monthly frequencies (the monthly tables show a running 18 month period).

The monitor incorporates all six-digit harmonized trade system (HTS) codes contained within Steel Mill Products, which totals about 180 codes. Please refer to the website for the list of HTS codes monitored. The monitor is broken into two separate sections, one for Intra-NAFTA imports and another for External NAFTA imports. The resulting tables can be viewed in either a summary table format or by using the menu options on the right of the main page.

*Canada reports re-imports which is why the table below shows imports from Canada under Canada.
